1	<p>8 marks AO1</p> <p>AO1 will be used by candidates to demonstrate knowledge, understanding and specialist language and terminology when responding to the question.</p> <p>Candidates may refer to the following.</p> <ul style="list-style-type: none"> • The suffering of God is the direct consequence of God’s decision and willingness to suffer. • Moltmann claims that in the crucifixion, it is not just Jesus who suffers and dies, but also God in his divine nature that suffers. • Moltmann’s view that the cross offers a powerful presentation of the depth of God’s love. • Weinandy maintained that a God who is impassable is more loving and compassionate than a suffering God. • Weinandy argues that Moltmann is wrong in thinking that God has to feel like us, in his divinity, to know our pain; God’s knowledge does not have to be physical knowledge. Such responses will be underpinned by their use of knowledge and understanding.</p> <p>Candidates may refer to the following in relation to AO2.</p> <ul style="list-style-type: none"> • The Bible's role as a source of authority is important because Christianity is based on the Bible that Christians accept as being inspired by God. • The Bible's role as a source of authority is important because it is the way through which God has revealed who and what he is and does. • It is important for Christians because it is the first authority that informs their beliefs, decisions and moral behaviour. • However, the importance of the Bible's role as a source of authority can be challenged because it was compiled by humans and therefore the notion of it being definitively the word of God is less convincing. <p>Candidates who show achievement only against AO1 will not be able to gain marks beyond the top of Level 1.</p>	(9)

Candidates will be required to demonstrate knowledge and understanding using specialist language and terminology when responding to the question, and in meeting AO2 descriptors described below.</p> <p>Candidates may refer to the following in relation to AO1.</p> <ul style="list-style-type: none"> • God as the author of personhood in the created universe, cannot be less than personal himself. • Scripture assumes that God is personal as reflected in the use of personal pronouns. • The Christian act of prayer demonstrates that God experiences relationships with other persons, or self-conscious beings. <p>AO2 requires candidates to develop their answers showing analytical and evaluative skills to address the question. Such responses will be underpinned by their use of knowledge and understanding.</p> <p>Candidates may refer to the following in relation to AO2.</p> <ul style="list-style-type: none"> • God is identified by Christians as being endowed with rationality, self-consciousness and volition therefore the implication is that these are qualities associated with being a person. • One implication of God as personal is that God is like us, therefore he is someone who Christians can engage with in a personal way: for example, through prayer. • Another implication of God as personal is shown in the Christian understanding of the Trinity because the Trinity reflects the communal, personal nature of God. • However, the idea of a personal God for Christians could be viewed as anthropomorphic and therefore the implication that God as personal is merely a projection of human self-centred yearning. <p>Candidates who show achievement only against AO1 will not be able to gain marks beyond the top of Level 1.</p>

Candidates will be required to demonstrate knowledge and understanding using specialist language and terminology when responding to the question, and in meeting AO2 descriptors described below.</p> <p>Candidates may refer to the following in relation to AO1.</p> <ul style="list-style-type: none"> • Many of the world’s great artists have used religious themes in their paintings, particularly the Crucifixion or Nativity. • Poetry has regularly been used as a way to express religious belief and wonder. • Types of architecture and different buildings have been developed to reflect Christian belief. <p>AO2 requires candidates to develop their answers showing analytical and evaluative skills to address the question. Such responses will be underpinned by their use of knowledge and understanding.</p> <p>Candidates may refer to the following in relation to AO2.</p> <ul style="list-style-type: none"> • Creative expression is significant for Christians because the Christian community is strengthened when expressing collective identity and belief. • Art is a visual expression in Christianity that is accessible for all and therefore is significant because it is a potent and effective form of creative expression. • Music as a creative expression is significant because it can stimulate and inspire a personal and/or collective encounter with God. • Language as a form of creative expression is significant because it can convey the beliefs of Christianity without the necessity for collective participation. • Creative expression may not be significant because ultimately it is a subjective matter and differing types of creative expression suit different people and communities and some people even find them unnecessary. • Creativity is believed by Christians to be a gift from God and therefore creative expression is significant because it is considered a spiritual response and act of worship. <p>Candidates who show achievement only against AO1 will not be able to gain marks beyond the top of Level 1.</p>
